Annual Meeting Report

APRIL 29,2006

The 2006 Annual Meeting was held at the Chateau Resort and Conference Center in Tannersville, PA. There were 15 members in attendance: WA2OCL, K2IB, W3ICX, KC2GHT, N2COM, W3EOP, N2CJ, WY3T, W4WZR, W4HJL, K3RIZ, W3ILG, K2QIJ, W1RXH, and N3KYK.

All who were in attendance were asked to stand and identify themselves and give a few brief statements. Each of the officers, directors, and the net manager were given the opportunity to address the members.

Charlie Stampf N2CJ presented the treasurer's report and provided several handouts (1) A detailed transaction report from 1-1-2006 through 4-30-2006 (2) an income/ expense by category, 2 reports from 4-1-2005 through 4-28-2006 and (3) an income/expense by category, 2 graphs depicting income vs. expenses month by month from 4-1-2005 through 4-28-2006.

Joe WY3T gave the net manager's report. He addressed the membership and read a statement of thanks to all of the net control stations for the outstanding job they have done under very trying band conditions. He presented a framed certificate of appreciation to each NCS. The remaining certificates will be mailed to the net control stations who didn't attend the meeting.

Paul McBride W3ILG described a proposal for the 2007 annual meeting. There are no significant changes from this year's contract except that we asked them if we could have a banquet Saturday evening after the meeting. Detailed information will be available when Mick gets the formal proposal document.

There was no old business to discuss.

The only new business was the request by Charlie N2CJ for an ECARS capitol equipment fund for future equipment purchases.

Next, the membership was provided with a review of the accomplishments of the past year. I described the new tri-fold brochures and pencils that have been generated to help with advertising ECARS. I described to the group how I have spoken at several amateur events in the Maine area,

ARRL Approves ECARS for Affiliation

On April 26, 2006 the American Radio Relay League (ARRL) approved the East Coast Amateur Radio Service (ECARS) application for affiliation with ARRL. Over the past several years, affiliation with the ARRL has been considered but no action was ever taken. Early this year I contacted several people at ARRL and requested the necessary forms and applications required to achieve affiliation. It is generally a fairly long process to receive approval. This year approval could have taken longer due to the untimely death of one of the members of the ARRL executive committee.

In early February we submitted the necessary information required by the ARRL for affiliation approval. Early in the process I had many conversations with Norm Fusard and Gail Iannone. I asked them what the possibility would be for us to get approval before our annual meeting in Tannersville, Pa. on the April 29. Both Norm and Gail said they would do everything they could to help us meet our April annual meeting date. I am happy to report that we received our affiliation approval on April 26, the day before I left for the annual meeting in Tannersville, Pa. I was able to announce the successful completion of this venture at the annual meeting.

bringing attention to the ECARS organization. I have made the brochures available at the functions and have given some to the club presidents to be handed out at their discretion. This affiliation has a long trail connected to it and many thanks need to be given to all of those who have been involved in seeing this to come to fruition.

I informed the membership about our application for liability insurance. I am still waiting for some paperwork before that will be completed.

I told everyone about the article we are putting together for QST. Finding old material about ECARS is more difficult then I had expected. I have asked everyone to be on the lookout for old material, past Monitors, and any old pictures. An article in QST would be a big boost to the organization and could have a significant effect on our membership numbers.

Other accomplishments by the board include the adoption of the 2005 ECARS Election Ballot Counting Committee Rules of Procedure and approval of the increase of annual ECARS dues from \$7.50 to \$10.00, approval of the formal Swap & Shop use policy, approval to purchase HTML editing software, approval of the motion to appropriate funds to update ECARS web; i.e. page coding to make it functional in response to changes by IPS owner, and approval to appropriate funding for web site remedial work.

At this time we opened the floor for additional comments. Charlie N2CJ requested that a motion be made to allow him to take \$500.00 a year out of the checking account and put it into the ECARS capitol equipment account. He sited several things that will need funding in the near future. The motion was made, seconded, and approved. There were no action items from the meeting.

The meeting was concluded at 12 o'clock noon. This was an excellent annual meeting with a warm and friendly atmosphere. Thanks to all who made contributions to this very successful meeting and great weekend with all the wives and friends who accompanied the members. A very special thanks goes to Al Prindle KA3UNB and his wife who made all the arrangements for the 2006 Annual meeting.

Cooling Fan Modification IC-7000

I have seen modifications that hack cables and use electrical tape. I know you don't see the mod once it is done but I like it when they are a bit neater. The following is a cooling fan modification to allow the fan on the IC-7000 to operate at a low speed whenever the rig is turned on. However the fan still runs at full-speed when the radio is transmitting.


Required material: three 33 ohm $\frac{1}{2}$ watt resistors, one 1N4004 diode, and a piece of insulating tubing to fit over the resistors.

First remove the eight screws that hold down the top cover of the IC-7000. There are two on the top front, two on each side, one on the top back, and one right in the middle of the top. DO NOT remove the speaker screws.

Gently remove the top cover with the speaker and wires attached, and place it to the side.

Refer to photo Fan Mod #1. This is the finished mod.

I installed the diode directly to pin 2 on the circuit board looking left to right.



Fan Mod #1


Inside the black tubing are the three 33 ohm resistors in series. The white stripe side of the diode is fastened to one side of the resistor pack and the other side of the resistor pack is fastened directly to the circuit board where the "fan" socket is fastened. Fan Mod #2. Solder to the same pin that the red wire from the fan is connected to.

I used a 15 watt iron and very thin solder. In order to solder to the base of the fan socket you will first have to unplug the two gray cables and push them out of the way.

After the mod is completed you can re-assemble the radio. No radio reset is needed.

The fan will now start at a low speed when you turn on the radio. You will notice that the radio runs cool while receiving instead of getting hot as before the mod.

The fan will speed up while transmitting as it did before the mod.

Is Ham Radio Dying

or just deaf, dumb, and blind?

Whether you believe that our hobby is healthy and growing or sliding down the slippery slope, one thing is fairly clear. The average age of the American amateur radio operator is slowly moving into the high 50s. I wonder how many of those operators are also retired.

Now that I've got your interest let me get to the real subject of this article.

Recently, I was in a QSO with a fella in his 60s. He was talking to me about his new IC-7000. I've heard a few of these new rigs and they all sounded pretty good. However, this guys didn't sound that good. I think he tinkered with the settings so much that he actually took a pretty good sounding signal and degraded it.

So, I was talking to him and listening mostly to him go on about the radio. It's a beautiful rig and I'm curious what owners think about these IC-7000 transceivers and how they think the radios perform. About 15 minutes into the QSO two other stations asked to join the QSO. This time one station was another older ham and the 3rd was a "newly" licensed operator about 14 yrs old.

The two older hams started chatting away completely ignoring the young operator. This went on for several minutes. Fact is they weren't following a round-table format. I finally doubled with one of them and directed to the young operator to move up frequency where I would QSO with him. The frequency change was successful and I hope he wasn't too put-off by the behavior of the other operators.

For those of you that care a great deal about this hobby you might consider making a point to scan the bands once and a while to look for young/newly licensed operators calling CQ. Take the time to give that new operator a good contact and an interesting QSO. Ask engaging questions. Make the operator feel comfortable and also remember, although you may hear something on the air that you don't particularly approve of, do the hobby a favor and keep your thoughts off the air. Don't come down on the newly licensed operator just because he might not have the right technique figured out yet.

If you want to pretend you are the "radio police" send the person you think is using inappropriate operating practices an email but don't create a scene on the radio. It just causes ill will and make us all look bad. Remember, not one of us is perfect! This advice goes for those of us on 7255. Remember ECARS doesn't own 7255. If you hear stations using the frequency in QSO mode, leave them alone. They have every right to use that frequency, they were there first, obviously. Breaking them to ask if you can start the net is not appropriate NCS behavior. A better solution would be to join the QSO, engage in the conversation and then interject your interest in ECARS, letting them know that when the QSO has finished they are welcome to check-in with you as you plan to start the net, etc. Lets show all these new stations we're now hearing due to the down turn in solar activity that ECARS is run by gentlemen, not hot heads or frequency hogs who'll do almost anything it takes to run the net at their favorite operating time

Keep the Hobby Alive.

Utilizing Ham Radio Volunteers

as back-up for public safety in Arlington, VA by Dave Jordan, WA3GIN

Here's how emergency managers develop a Radio Amateur Civil Emergency Service (RACES) program, which works. Most important is that you need several municipal employees who are licensed amateurs to volunteer to work for the Office of Emergency Management (OEM). There is a great benefit to having a government employee head up your volunteer efforts. Without doing so, the municipal government risks having volunteers with no real accountability. OEM then never really knows whether the volunteers are well trained, practiced, and drilled, etc.

When you empower a municipal employee to act as RACES officer who reports to OEM and is responsible to the local government, all of a sudden you have accountability and a focus point. The Federal Emergency Management Agency (FEMA) RACES format described in the Civil Preparedness Guide 1-15 works because it was designed to fit comfortably into how local governments operate.

Many localities know and use amateur radio operators affiliated with SKYWARN, REACT, ARES, CAP, MARS, etc. but RACES doesn't compete with those volunteer groups. RACES is the straightforward method for a local government to embrace radio volunteers with a more formal requirement for background checks, specific skill sets and mandatory training, testing, and drills.

I recommend, that emergency managers who are using a loose association of amateur radio volunteers, go to the FEMA web site and read up on RACES. I think they will find out that there are important benefits in following the recommendations and best practices associated with a more formal structure which provides local control of the implementation and incorporation of radio volunteers into emergency response. The benefits are spread across both the local government and the volunteers, something that just doesn't exist with the "club" affiliations.

RACES is not a club, it is really a methodology. Volunteers who think they can offer the same level of services via a "club" affiliation just don't get it. Maybe that is the filter to be used if volunteers are resistant to following the recommended RACES practices, and perhaps you don't want them as volunteers.

Arlington County Virginia has raised the bar signifi-(Continued on page 7) (Utilizing Ham Radio Volunteers continued from page 6)

cantly for its radio amateur volunteers, beginning with the successful completion of a county character background check and then going to twice monthly training classes based on FEMA and other known emergency communications training materials (NIMS ICS - 100 - 800).

Here in Arlington, training is provided by the County Safety Officer (who is also an amateur operator K3SRF). The training is provided via the Internet using a WEBX format. This way volunteers don't have to leave home or take time during the weekend to attend the training sessions. The PowerPoint/PDF presentations are hosted on the local club web page www.w4ava.org along with the related audio WAV files. For those volunteers who are frequent travelers or if they miss a class, they can catch-up at their convenience using the web site links.

Arlington currently has more than 30 RACES volunteers enrolled in the County's text alert system so that text alerts can be sent to remind members of the scheduled training classes and/or the weekly evening emergency net exercises.

What all of us used to think worked pre-9/11 is no longer sufficient with regard to radio amateur volunteers. Individuals who cannot appreciate the need for background checks can volunteer in other ways, perhaps, but it makes no sense for a locality to place volunteers into the heart of OEM operations without having at least some minimal level of certification.


